First ASA report by Maria Virgillito

Many times during this last year we've told ourselves "Everything is going to be fine" and, especially as an Organization that has been dealing with minors for more than twenty years, we did repeat several times "Everything is going to be fine ... for our children and for all mothers and fathers", that is to say for all Asa's families.

In the difficulties of the pandemic, at an unprecedented historical time during which the world has suffered a setback, solidarity has never stopped and, an Authorized Organization for International Adoptions, we have not witnessed any decline in the numbers of conferral of assignment, and have achieved excellent results for adoptions.

This Report gives indeed evidence of that, outlining the data of 2019 and the year just ended: they're not just numbers, since behind them are hidden stories of parents, children and adolescents, stories of hopes, stories of waiting times which came to an end and much desired hugs. This is the first Report that the Organization has drafted with the aim of disclosing the data relating to the adoption procedures and, similarly, a tool to reflect on the work that we carry out day after day, to enhance the services offered to our families.

Over the last year, we have certainly struggled to respect, with responsibility, the rules imposed both in our country or in the countries of origin of minors.

All this has been possible thanks to valuable teamwork, CAI's support, the involvement of the reference Central Authority of each host country and the diplomatic representations.

From 2001 to today, 1133 minors have found the warmth of a family thanks to Asa. There are 1133 stories to tell and 1133 are the times in which our Organization was able to enjoy the miracle of family hospitality.

As president of ASA Onlus, in recent years, I have worked hard to ensure that the best interest of the child does not merely remain a statement of principle, but finds application in all the steps of the sometimes-complex process that leads to the birth of new families.

Several achievements have been reached: from improving the quality of the services offered to the couples, to the expansion of the offices operating throughout the country, to the increase in the number of the countries in which we operate.

We need to keep up with the times, with cultural progress and innovation in the International Adoption sector, and with all the challenges that we will continue to face with courage and dedication.

Therefore, it is necessary to improve our Organization day after day, to try and always satisfy the needs of children, adolescents, parents and future families, building relationships based on trust and professionalism.

Always by the children's side by Fulvio Giardina

For over twenty years, ASA Onlus has been promoting and sharing the culture of solidarity, justice, consistency, courage, trust, in every action aimed at protecting the real needs of all children.

These are moral values that underlie the adoptive path, whose aim is to guarantee an affective, stable and lasting reference point to a minor in a state of abandonment, the right to live, grow and be educated within a family.

In other words, adoption is not just a mere formal, bureaucratic act, but a real path of regeneration for the adopted child and for the couple adopting them.

The concept of "family", like that of any other social aggregation, has changed over time, constantly adjusting to the changing conditions of life. Suffice it to say that civil marriages, which were 2.3% in 1970 and 36.7% in 2008, are as much as 50.1% in 2018. The number of children born out of wedlock, which was 8, 1% in 1995 and 19.6% in 2008, it is 32.3% in 2018.

The persistent decline in the birth rate in our country has reached very worrying levels, compared to the other G20 countries. The average number of children per woman dropped again to 1.27 in 2019 (it was 2.7 in 1964, 1.46 in 2010).

In 2019, 420.000 children were born in Italy, the lowest number in over 150 years of National Unity!

Certainly, given the high number of children living today in a serious state of decay and neglect, we would like an easier adoption path, free from unnecessary bureaucratic delays (we still cannot understand why the assessment of the adopting couple should be borne by the Health National Service), and above all supported by the State, as is the case for biological births.

In the document "New Essential Levels of Assistance" (NLEA, DPCM of 12/01/2017), which lists all the services provided by the National Health Service and payable in every Italian health facility, all the medically assisted procreation services are clearly included, both those homologous and heterologous, even with respect to the outpatient specialist care, including genetic counseling, the necessary psychological support, brand new technologies.

In other words, we would finally like to see that, in our country, the entry of the child into a family can be equally supported and promoted.

In fact, from 2001 to 2018 in Italy 75.252 minors were adopted (45.472 foreigners, 18.566 Italians, 11.214 for special cases): numbers showing the presence of a widespread, consolidated adoption culture.

2020 will be remembered for entire generations, as those years that have characterized the history of humanity. The pandemic began with no prior warning, almost suddenly, like the start of a war. And in a short time, the tragedy of the many, too many, losses stroke. Each of us has lived a new life, unexpected in a highly technological era. The fight against an invisible enemy has begun. The mask, the limitation of our social and emotional relationships, the protective closure in our homes, the fear of contagion. We are no longer the same as before.

Are we better persons or have we closed ourselves even more? We will only know that over the next few years. That is, we will know if the strong emotions, the feelings we experienced, made us better. Certainly, however, abandoned children who met their adoptive parents this year, despite the limitations due to COVID, are the most beautiful sign of hope and joy.

1. The history of the Organization

ASA – Associazione Solidarietà Adozioni – Onlus mainly focuses on purposes of social solidarity with special emphasis on the protection of childhood and adolescence.

It was founded on May 6th, 1999, following a voluntary social commitment in favor of minors in a state of hardship in both Ukraine and Romania.

On May 30th, 2000, the statute of ASA was adapted to the rules provided for by Legislative Decree no. 460/1997 and subsequent amendments and additions on the subject of "ONLUS".

On May 8 2001 it was authorized by the Commission for International Adoptions (CAI) to operate as an organization for international adoptions pursuant to Law no. 476/98 (ratification law of the Hague Convention on the protection of children and cooperation in respect of adoption of May 29th 1993).

The **Organization** benefits from the professionalism of psychologists, social workers, legal consultants, foreign contacts and other specialized operators in Italy and at the foreign offices.

ASA is authorized to operate throughout the national territory with offices in **Catania**, **Palermo**, **Rome**, **Forlì**, **Taranto**, **Milan**, **Reggio Calabria**, **Bolzano**, **Lucca**.



Pursuant to Law no. 476/98, the Organization is authorized to carry out practices relating to international adoption in: **Europe** (Bulgaria, Moldova, Poland, Czech Republic, Slovakia, Ukraine, Hungary); Latin America (Bolivia, Brazil, Chile, Colombia, Ecuador, Honduras, Peru); Asia (Philippines, India); Africa (Benin).

2. Activities

2.1 International adoptions

ASA is committed to train couples who are approaching the adoptive project.

Thematic meetings and workshops are important moments of in-depth study of the themes of adoptive parenting and the establishment of family ties.

The Organization:

- organizes group and couple meetings, led by psychologists, in which the typical topics of international adoption are addressed: the reality of the child's country of origin, management of waiting times, meeting with the child

- manages all the procedural aspects related to the adoption process by communicating with CAI and with the competent foreign Authorities

- draft the post-adoption reports communicating, according to the procedures established by each country, the family, school and social integration of the adopted minors

- ensures a consultancy service for the containment of any problems in the *post*-adoption phase

- organizes moments of meeting and aggregation between families and minors

- complies with the regional protocols for the collaboration between local services, authorized Organizations and the Juvenile Court, in matters of national and international adoption

- is constantly in contact with CAI

- participates in institutional coordination tables.

ASA carries out information activities on the territory for those who intend to undertake the adoptive process, giving indications on the procedures and competent services for the area, through the support of information desks and distribution of information material.

2.2 International cooperation

In line with the principle of subsidiarity, laid down by the Hague Convention, ASA develops international cooperation projects both in the countries in which it operates as an Authorized Organization for international adoptions, and in other countries in which it has investigated the opportunity to take action for improving the condition of childhood and adolescence.

In particular, the initiatives concern:

- analysis of the local needs for structures and services
- psychomotor rehabilitation interventions for children with disabilities
- training of local operators so that they can independently develop analysis and intervention tools
- running professional training courses for neglected adolescents and designing internship experiences

2.3 Information sharing and training activities

ASA promotes an intense awareness-raising activity aimed at supporting minors, women in difficult conditions and families at risk of marginalization through:

- conferences and study seminars
- family mediation and parenting support activities
- training courses for teachers and school operators
- hospitality and multicultural projects

The Organization, within a broader framework of continuous training of operators, participates in the following projects: Erasmus +, the European Program for Education, Training, Youth and Sport.

2.4 Support programs

2.4.1 Distance Support Program

With Distance Support we have the possibility of giving hope and opportunities to children lacking adequate assistance, thanks to the creation of collaboration agreements with international realities in the Democratic Republic of Congo, the Philippines and Kenya where we support growth, school training and medical and psychological assistance for minors in difficulty, especially when the family situation does not allow them to grow peacefully.

In particular:

• in Congo, the "SOS Kinshasa Street Girls" program, in collaboration with the NGO GSItalia, makes it possible to support, in the city of Kinshasa, with a high incidence of prostitution, the first reception center where minors, victims of violence are supported from a medical, legal and psychological point of view

• in the Philippines, in collaboration with the Missionary Servants of the Blessed Sacrament, we support children on the Island of Mindoro, in particular in the villages of Tilaga and Paluan. These are very poor villages, with frequent cases of violence, abuse and kidnappings for political and financial reasons

• in Kenya, thanks to the collaboration of Father Douglas Mwija, we support the children of the village of Kangeta, where the situation is really critical. Here there are homeless children, in conditions of economic hardship and very often without any parental figure.

2.4.2 Neighborhood Support Program

Since many years, ASA has launched a Neighborhood Support Program aimed at safeguarding the rights of minors in the Italian territory, through the implementation of fundraising campaigns whose proceeds are entirely donated to projects in favor of minors and families in need.

In particular, thanks to the "Adopt a story" project, canteen vouchers and teaching materials were purchased for some schools in the area, for minors at risk of hardship and marginalization and shopping vouchers to support families in difficulty.

The collaboration with other Organizations and parishes in the area is of fundamental importance for the realization of the project.

2.5 Institutional Relationships

ASA is a member of:

• the Scientific Committee of the Commission for International Adoptions - Instituti degli Innocenti (pursuant to art. 15 of Law no. 241/90), which deals with Remote Training for operators

• LIAN - Life in Adoption Network, a partnership made up of 5 entities authorized for international adoption (ASA, CIFA, Ai.Bi - Amici dei Bambini, Ariete, Fondazione Nidoli) aimed at launching a common path, sharing methodologies and professionalism to provide support to Italian couples who intend to adopt a minor in another country

• CEA – Coordinamento Enti Autorizzati - a non-profit Organization, established in 2005 following the initiative of some Authorized Organizations, that promotes the collaboration between all the parties involved in the adoption process

• the Board of Directors of ForumSaD, permanent Forum for distance support, which deals with the promotion of SaD as an instrument of cooperation and solidarity between peoples

• the Regional Coordination for Childhood and Adolescence, in the Emilia Romagna Region, where a regional technical table has been set up on the subject of adoption

• the Council of Family Organization's, to the Municipality of Forlì, with consultative and representative functions, and participates in the development of municipal family policies in close relationship with the Administration.

The Organization has also entered into a Training and Orientation internship agreement with the University of Catania - Center for Orientation, Training and Placement.

3. Presentation and analysis of couples and minors data relating to adoptive procedures

3.1 Introduction

The data of couples and minors of the adoptive procedures are hereby presented and analyzed, through specific graphs, for the years 2019 and 2020.

Considering the particularity of 2020, it was decided to make a comparison with the previous year, in order to see to what extent the pandemic has affected the number of conferral of assignments and the entry authorizations.

Relevant dimensions are analyzed, for each of them some points of particular interest are examined in depth to highlight the work of ASA.

Couples who have conferred the assignment: conferrals of assignments by year and conferrals of assignment by office.

Couples who have conferred the assignment in 2019 and 2020 and who are still followed by ASA: conferrals of assignment by year, conferral of assignments by office, years of birth, educational qualification, profession, country choice.

Adopted minors: number of children by year, children by office, age, gender, number of children adopted by couple, country of origin.

Couples who have adopted: couples who have adopted by year, couples who have adopted by office, years of birth of couples, countries of origin by couple.


Thanks to this work, a meta-reflection is also carried out on all the phases relating to the adopted procedures.

The pandemic had a significant impact on 2020, but all ASA staff managed to limit the consequences and in various situations found optimal solutions that have largely overcome the obstacles posed by the ongoing emergency situation.

Skills, culture, action based on scientific evidence, the relevant attention to the specific aspects of the person, care of communication and relationships, the constructive local, national and international relationships; the values of consistency, cohesion, sharing, co-responsibility, synergy, cooperation, ethics; careful planning and implementation activities, targeted monitoring and evaluation actions, the fundamental meta-reflection were all decisive.


3.2.1 Conferral of assignment by year






In the comparison, between 2019 and 2020, the offices of Forlì, Catania and Palermo have registered an increase in the number of assignments.

A decrease has been registered for the offices of Reggio Calabria, Rome, Taranto and Milan.

Bolzano remained unchanged.

3.3 Couples who have conferred the assignment in 2019 and 2020 and who are still followed by ASA

3.3.1 Conferral of assignment by year





For couples still followed on 31-12-2020, reference is made to the adoptive procedures underway and to the families followed during the post-adoption period.

The couples who have conferred the assignment in **2019** are 48, 8 of which have revoked the mandate:

- 4 for national adoption
- 1 for cancellation by the Entity
- 2 for personal reasons
- 1 for pregnancy.

From the analysis of the 40 remaining couples from 2019:


- 13 have adopted
- 26 are pending
- 1 suspended the process for personal reasons.

48 couples have conferred the assignment to the Organization in **2020**, 2 of which have revoked it in favor of national adoption.


Of the 46 remaining couples of 2020:




Analyzing the data of the couples who have appointed ASA in 2019 and 2020 and who are still followed as of 31-12-2020, it should be noted that between 2019 and 2020:

- •the offices in Reggio Calabria, Rome and Taranto had a lower number.

3.3.3 Years of birth








Conferral of the assignment (C.A.). Procedure through which families appoint the Organization.








3.3.5 Profession







The profession most represented is that of the employee.



The Czech Republic and the Philippines follow far behind.


In 2020 it is also possible to find Slovakia.

By analyzing 2020 it is possible to notice that 4 couples have not chosen the country yet, and 12 couples have made a double choice.

More specifically, in the double choice, Hungary is confirmed as the preferred country, followed by the Czech Republic and, significantly far from that, the choice falls on Slovakia, Ukraine and the Philippines.


The difference in the number of minors adopted is mainly due to the pandemic, which did not allow travelling, based on the decisions of the various States.

After the end of the lockdown, and the definition of the agreements with foreign countries, a significant number of entries took place; in fact, in the last 5 months of 2020 as many as 25 minors entered.


Another variable is that in 2019 the entry authorizations per couple concerned, to a considerably greater extent than in 2020, more than one minor, as it can be seen from graphs n. 25 and n. 26.


Considering these two variables, it can be argued that the number of couples having adopted one or more children in 2020 was significant.

3.4.2 Children by office






Taking into account absolute numbers, all the offices have witnessed a variable decrease in admissions, due to the pandemic, as specified above.

If we analyze the percentages, Forlì has experienced an increase, Taranto and Rome have been almost steady, Bolzano, Catania, Milan and Palermo have experienced a decrease.

The Reggio Calabria's office, operational since November 2019, has only been included in the 2020 charts (charts n.19 and n.20).





3.4.4 Gender










In 2020, the adoption of only one child per couple remains almost constant, compared to 2019.







In 2020 we are witnessing a decrease with respect to the number of couples who have adopted, compared to 2019, due to the pandemic.


3.5.2 Couples who adopted by office




Considering the absolute numbers, in 2020 there was a variable decrease for the various offices.


In percentage terms, it is possible to highlight a substantial increase for Forlì and a minimum one for Taranto.

3.5.3 Years of birth of couples







4. Conclusions

Taking the data into account, it can be noted that the pandemic has not affected the appointments, confirming the commitment of our operators and the strong presence of the Organization in the territory. Professionalism and dedication, at such a delicate time, have been the flagship values of ASA.

The number of couples who has adopted has suffered an inevitable decrease, but the number of entry authorizations shows how our reference persons and operators have consolidated the already excellent relations with the institutions of the countries in which we operate.

During the pandemic, ASA strengthened its support to couples and families in Italy and abroad.

All couples and families were guaranteed constant psychological support thanks to the use of online platforms. All the meetings were virtually scheduled and during the lockdown the staff ensured their complete availability.

Abroad, the Organization's commitment has been continuous in communicating with the Italian Embassies of the countries in which it operates, adjusting the *pre*-departure process, the stay on site and the *post*-adoption procedure to the applicable regulations.


The most represented age ranges for adoptive couples are 1970-74 and 1975-79. Furthermore, in 2020, there is an increase in the 1980-84 range.

The level of educational qualification of couples is high and medium-high: degree and high school diploma.

The type of work most represented is that of the employee.

As regards the age of minors, the most represented age group is 6-8, followed by 3-5 and 9-11. Both in 2019 and 2020 there was only one minor adopted in the 12-14 band. In 2020 there were 3 adoptions in the range up to 2 years.

From the analysis of the data it is therefore possible to highlight a constructive and fruitful work carried out by ASA's staff with culturally and scientifically based targeted interventions, based on the enhancement of the personal and community dimensions, on the affirmation of life as a relationship of love, respect and gift.
